## WHAT IS A TECHNICAL DEVELOPMENT APPLICATION?

A Technical Development Permit is required for any intended alteration of land, subdivision, construction or significant alteration of a building or structure on land located within a protected sensitive environment, foreshore or hazardous Development Permit Area. Minor Form & Character Development Permits may also be issued as Technical Development Permits.

## WHAT IS THE APPLICATION PROCESS FOR A TECHNICAL DEVELOPMENT PERMIT?

- 1** Complete application is prepared and submitted to the District by the applicant. Incomplete applications will not be accepted
- 2** Upon submission of a complete application and required fee, a file is opened
- 3** The Planning & Development Services Department evaluate the proposal and refer the application to internal departments and/or external agencies (as applicable)
- 4** Planning Staff work with the applicant and the applicant's qualified professionals to ensure all Official Community Plan Development Permit Guidelines are adequately addressed
- 5** The Planning & Development Services Dept. prepare a Staff report for consideration by the Director of Planning & Development Services
- 6** Once approved the Planning & Development Services Department notifies the applicant and the applicant proceeds to satisfy the conditions of the permit
- 7** Upon approval a Notice of Permit is registered on the title of the subject property at the Land Title Office
