



ALTERNATIVE APPROVAL PROCESS Elector Response Form Water Treatment Plant and Water Interconnect

By completing and signing this Elector Response Form, I am **OPPOSED** to the District of Peachland's intention to adopt Peachland Water Treatment Plant and Interconnect Loan Authorization Bylaw No. 2208, 2017, which authorizes the borrowing of up to NINE MILLION, TWO HUNDRED AND EIGHTY-FIVE THOUSAND, FOUR HUNDRED AND FIFTY-SIX DOLLARS (\$9,285,456), to be repaid over a period not exceeding 25 years, for the construction of Peachland Creek Water Treatment Plant and Trepanier Creek Water System Interconnect to provide treated water through a conventional water treatment process within the boundaries of the District of Peachland.

I, the undersigned, hereby certify that:
