Community Amenity Contribution Policy (DEV-100):

- Residential: \$1877/unit
- Commercial and industrial: \$26.80/m²
- Projects with less than three units are exempt

Secondary Suite – Peachland DCCs are not applicable; RDCO DCC fees (Regional Wastewater Treatment Plant) are required at time of building permit if construction value exceeds \$50,000

Garden Suite – Peachland, School District, and RDCO DCC fees (Regional Wastewater Treatment Plant) are required at time of building permit if construction value exceeds \$50,000
