

## Protective Services Building Land Requirements Increase

At a Special Meeting on Thursday, July 24, Peachland Council rose and reported that it will pursue the purchase of additional land for the construction of the Peachland Protective Services Building.

Mayor Patrick Van Minsel reported on behalf of Council that the two properties that have been assembled for the project are not adequate to meet the future needs of the emergency services building and more land is needed.

"The District is in communication with the Peachland Baptist Church to discuss purchasing its 4204 Lake Avenue property with an option that would fully support Peachland Baptist Church by professionally relocating its building to a nearby site within the same neighborhood," said Mayor Van Minsel.

In a 2022 referendum, Peachland residents approved the borrowing of up to \$17.5 million to build the new Peachland Protective Services Building which will house the firehall, BC Ambulance Service and Citizens on Patrol. The current facility at 4401 3rd Street is no longer suitable due to age, condition and increased service demands, and is not meeting regulatory requirements. Since that time, the District has purchased

property at 4223 San Clemente Avenue, adjacent to the municipally owned parcel at the corner of San Clemente Avenue and 13th Street. The new central location will meet health and safety regulations, improve response times and enable the District to more effectively support regional emergency activations.

"Council wholeheartedly believes that a mutually beneficial solution will be achieved and has directed the District to support the relocation of the Peachland Baptist Church, a deeply valued institution that has been part of the community for over 100 years," said Mayor Patrick Van Minsel.

The District's project consultants have determined that commercial construction costs have increased dramatically due to market volatility and price escalations, prompting the need to explore more cost-effective delivery models. In seeking a viable solution, the District has been examining a Public-Private Partnership (P3) approach to help offset rising costs and maximize the use of an expanded site. The property on which the Peachland Baptist Church is situated provides the needed space and strategic location for an expanded Protective Services Building to serve the community's long-term needs.

# **Strategic Priorities Fund Application Protective Services Building**

Council authorized the District's application for \$7 million from the Strategic Priorities Fund 2025 towards the building of the Peachland Protective Services Building. This opportunity opened in May through the Canada Community-Building Fund in BC (formerly known as the Gas Tax Fund) and is administered through the Union of BC Municipalities to fund capital construction projects, including firehalls. The application deadline is in September.

# Community Video Surveillance Update

Council approved an update to its Video Surveillance policy allowing the installation of cameras near areas where increasing vandalism is being observed. Cameras



will be installed outside of public washrooms at Swim Bay, the Peachland Museum and Todd Road lift station where acts of vandalism or property damage requiring cleanup, repairs and sometimes temporary closures has occurred. Bylaw Enforcement has also received multiple reports of people trying to access or inappropriately use these public facilities after hours. The District currently conducts video surveillance at Peachland Municipal Hall, the Public Works yard and the 50+ Centre (operated by Community Policing). The new cameras will be in addition to current security measures, like routine patrols, and should act as a significant deterrent. Video surveillance, including the privacy implications, is managed through the District's Video Surveillance Policy PRO-290, and adheres to the Freedom of Information and Protection of Privacy Act. The policy allows surveillance footage to be provided to the RCMP for criminal investigations. Surveillance will be practically minimized and will not take place in areas considered confidential, ie: change rooms/washrooms.

# Notice of Unpaid Property Taxes

The deadline to pay 2025 property taxes has passed and late penalties have been applied to all accounts with unpaid taxes or unclaimed Home Owner Grants. Property owners can still claim the grant for 2025 however, the grant will not cover any penalties owed. If you have unpaid property taxes, please ensure you have claimed your Home Owner Grant by visiting

or call 1-888-355-2700. If you qualify for a Home Owner Grant you must apply for it each year. The deadline to claim the grant is December 31, 2025 but late penalties are charged to accounts with grants claimed after July 2, 2025. Property owners with taxes in arrears are encouraged to make a payment to avoid further interest charges. Please note, municipalities are governed by provincial legislation and the District of Peachland does not have the authority to waive or alter penalties or interest charges.

## Council Highlights

### July 8, 2025 COUNCIL MEETING

Development Application and Licence Fees

Council gave first three readings to a Development Application and Licence Fees Bylaw Amendment to better reflect current costs of providing services, the staff time required to facilitate reviews and approvals, and to ensure fee alignment with area municipalities. The last major review of the current bylaw was in October 2015. Council requested adjustments to the recommended fees for short term rentals, which will be incorporated into the proposed bylaw for Council's consideration at an upcoming meeting.

4062 Beach Avenue Zoning Amendments

Council adopted a Zoning Amendment Bylaw to rezone 4062 Beach Avenue from Multi-Unit Infill Residential to Beach Avenue Mixed Use, making it the first property with the CR3 zone in Peachland. Conditions that Council had placed after third reading have been met including registration of a covenant restricting the development to a density of six units and a maximum height of 12 metres. The development included payment of \$11,262 for the Community Amenity Contribution.

Removal of Illegal Retaining Walls

Council imposed a remedial action order on 5475 Pierce Street for the removal of retaining walls built in contravention of the Building Bylaw. The walls constitute a hazardous condition as they were constructed using potentially toxic materials and without the benefit of a building permit. The order would direct the property owner to remove the structures, restore the slope under the supervision of a qualified professional, and provide confirmation that the site meets geotechnical safety standards. If the owner does not comply with within a specified time, the District will do the work and recover the associated costs from the property owner.
