BYLAW NUMBER 2275

A Bylaw respecting the enforcement of bylaw notices.

This is a consolidated bylaw prepared by the Corporation of the District of Peachland for convenience only. The Corporation does not warrant that the information contained in this consolidation is current. It is the responsibility of the person using this consolidation to ensure that it accurately reflects current bylaw provisions.

WHEREAS the *Local Government Bylaw Notice Enforcement Act* empowers the District to, by bylaw, designate those bylaws for which bylaw notice enforcement may be used as means of bylaw enforcement;

AND WHEREAS the Council of the District of Peachland must by bylaw, designate bylaw contraventions that may be dealt with by bylaw notice, establish the amount of the penalty for a bylaw contravention and establish a period for paying or disputing and bylaw notice;

AND WHEREAS a bylaw is required to authorize the enforcement of bylaw notices in conjunction with the Southern Interior Bylaw Notice Dispute Adjudication Registry;

NOW THEREFORE, the Council of the District of Peachland, in an open meeting assembled, ENACTS AS FOLLOWS:

PART 1 – CITATION

1.1 This Bylaw may be cited as “Bylaw Notice Enforcement Bylaw No. 2275”.

PART 2 – REPEAL

2.1 District of Peachland Bylaw Notice Enforcement Bylaw No. 2119, including all amendments thereto, is hereby repealed.

PART 3 – INTERPRETATION AND AUTHORITIES

Severability

3.1 If any part of this bylaw is held to be invalid by a court of competent jurisdiction, then the invalid portion must be severed and the remainder of this Bylaw is deemed to have been adopted without the severed portion.

Successorship of Delegated Authority

- 3.2 Words in this bylaw directing or empowering any officer or employee of the District to do any act or thing, or otherwise applying by name of office, includes successors in such office and any lawful deputy, and any person who is duly appointed to act in that officer or person's place.

References to Enactments

- 3.5 A reference to an enactment in this bylaw refers to an enactment of the Province of British Columbia unless otherwise indicated, and a reference to any statute, regulation, code, or bylaw refers to that enactment as it may be amended, revised, consolidated or replaced from time to time.

General Interpretations

- 3.6 The terms in this bylaw shall have the same meaning as the terms defined in the *Local Government Bylaw Notice Enforcement Act*.
- 3.9 The headings contained in this bylaw are for convenience only and are not to be construed as defining, or in any way limiting, the scope or the intent of the provisions of this bylaw.

PART 4 – DEFINITIONS

- 4.1 The following are definitions of terms used in this Bylaw:

“**Act**” means the *Local Government Bylaw Notice Enforcement Act*.

“**District**” means the Corporation of the District of Peachland or the area within the municipal boundaries thereof as the context may require.

“**Registry**” means the Southern Interior Bylaw Notice Adjudication Registry established pursuant to this Bylaw.

PART 5 – GENERAL REGULATIONS

Bylaw Contraventions

- 5.1 The bylaws and bylaw contraventions designated in Schedule ‘A’ attached hereto and forming part of this bylaw, may be dealt with by bylaw notice.

Offence and Penalty

- 5.2 The penalty for a contravention referred to in Section 5.1 is as follows:

- a) Subject to sub-sections 5.2(b) and 5.2(c), is the penalty amount set out in Column ‘A1’ of Schedule ‘A’;

- b) If payment of the penalty is received by the District within fourteen (14) days of the person receiving the bylaw notice, or being presumed to have received the notice, the “Early Payment Penalty” set out in Column ‘A2’ of Schedule ‘A’ applies; or
- c) If payment of the penalty is received by the District twenty-eight (28) days or more after the person received, or is presumed to have received the bylaw notice, the “Late Payment Penalty” set out in Column ‘A3’ of Schedule ‘A’ applies.

Period for Paying or Disputing a Notice

- 5.3 A person who receives a bylaw notice must, within fourteen (14) days of the date on which the person received or is presumed to have received the bylaw notice:

- a) pay the penalty, or
- b) request a dispute adjudication,

by filling in the appropriate portion of the bylaw notice indicating either a payment or dispute and delivering it, either in person during regular office hours, or by mail, to the District of Peachland.

- 5.4 A person may pay the indicated penalty after fourteen (14) days of receiving the bylaw notice but no person may dispute the notice after fourteen (14) days of receiving the bylaw notice.
- 5.5 Where a person was not served personally with a bylaw notice and advises the District, in accordance with the requirements of Section 25 of the *Act*, that they did not receive a copy of the original notice, the time limits for responding to a bylaw notice under Section 5.2, 5.3 and 5.4 of this bylaw do not begin to run until a copy of the bylaw notice is re-delivered to them in accordance with the *Act*.

Bylaw Notice Dispute Adjudication Registry

- 5.6 The Registry is established as a bylaw notice dispute adjudication system in accordance with the *Act* to resolve disputes in relation to bylaw notices.
- 5.7 The civic address of the Registry is the City of Kelowna, 1435 Water Street, Kelowna, BC, V1Y 1J4.
- 5.8 The District is authorized to enter into, and the Mayor and Director of Corporate Services are authorized to execute, the dispute adjudication system agreement in the form and with the content of the agreement in Schedule “B”, attached hereto and forming part of this bylaw.
- 5.9 Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the District an additional fee of \$25 for the purpose of the District recovering the costs of the adjudication system.

Screening Officers

- 5.10 The position of screening officer is established.
- 5.11 The following are designated classes of persons that may be appointed as screening officers:

- a) Director of Planning and Development Services;
- b) Manager of Planning
- c) Manager of Building Inspections and Bylaw Enforcement;
- d) Bylaw Enforcement and Licencing Officer; and
- e) Director of Corporate Services.

Council may appoint Screening Officers from these classes of persons by name of office or otherwise.

Powers, Duties and Functions of Screening Officers

5.12 The powers, duties and functions of screening officers are as set out in the *Act*, and include the following powers:

- a) Where requested by the person against whom a contravention is alleged, communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention allegation is based, the penalty for a contravention, the opportunity to enter into a compliance agreement, the opportunity to proceed to the bylaw notice dispute adjudication system and the fee or fees payable in relation to the bylaw notice enforcement process;
- b) To communicate with any or all of the following for the purposes of performing their functions under this bylaw or the *Act*:
 - i. the person against whom a contravention is alleged or their representative;
 - ii. the officer issuing the notice;
 - iii. the complainant or their representative; and
 - iv. the staff and records of the District of Peachland, City of Kelowna, or Regional District of Central Okanagan regarding the disputant's history of bylaw compliance.
- c) To prepare and enter into compliance agreements under the *Act* with persons who dispute bylaw notices, including to establish terms and conditions for compliance that the Screening Officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
- d) To provide for payment of a reduced penalty if a compliance agreement is entered into, as identified in Column 'A4' of Schedule 'A', and
- e) To cancel bylaw notices in accordance with the *Act* or District policies and guidelines.

5.13 The bylaw contraventions in relation to which a Screening Officer may enter into a compliance agreement are indicated in Schedule 'A'.

5.14 The maximum duration of a compliance agreement is one (1) year.

Bylaw Enforcement Officers

5.15 Persons acting as any of the following are designated as Bylaw Enforcement Officers for the purposes of this Bylaw and the *Act*:

- a) Special constables, officers, members or constables of

- i. The provincial police force as defined in Section 1 of the *Police Act*, or
 - ii. A municipal police force; or
 - iii. The Royal Canadian Mounted Police Force.
- b) Bylaw Enforcement Officers appointed pursuant to the *Police Act* and *Community Charter*;
- c) Local Assistants to the Fire Commissioner under Section 6 of the *Fire Services Act*;
- d) Licensing inspectors, bylaw enforcement and licencing officers, building inspectors, animal control officers or other persons acting in another capacity on behalf of a municipality, regional district, or local trust committee for the purpose of enforcement of one or more of its Bylaws.

Form of Bylaw Notice

5.16 The District may from time to time provide for the form(s) of the bylaw notice, provided the bylaw notice complies with Section 4 of the *Act*.

This Bylaw shall take effect upon its adoption by the Council of the District of Peachland.
