New Fire Hall Project Moves Forward



Peachland's long-awaited new fire hall has taken a major step forward with Council awarding the design-build contract to Chandos Construction LP, in partnership with Sahuri + Associates Architecture.

The 17,000-square-foot facility will be built on San Clemente Avenue and will feature eight apparatus bays, dedicated space for community policing, a rescue training tower, and modern facilities designed to meet current National Fire Protection Association standards. The project will significantly enhance emergency response capabilities and support firefighter training for years to come.

On July 7, Council adopted the required Official Community Plan and Zoning amendments, after receiving Ministry of Transportation and Transit approval.

The project remains on track to be completed within the approved \$17.5 million budget, which includes land acquisition, design, consulting, and construction costs. Detailed design work is now underway, demolition of the existing building is expected this summer, and the new fire hall is anticipated to be operational by the end of 2028.

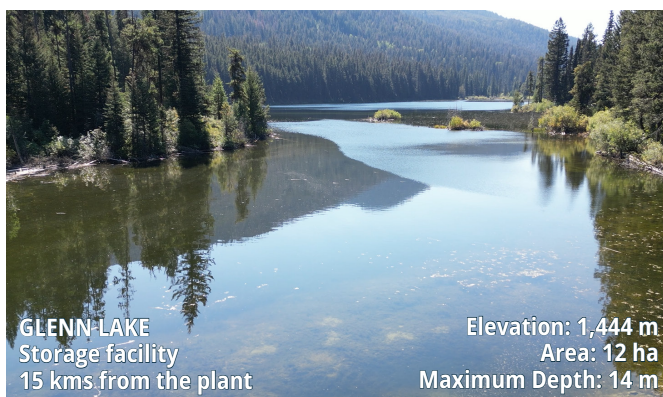
How can we protect Peachland's water supply?

PEACHLAND LAKE
Provides 100% of Peachland's
potable water. Located 21 kms
from the water treatment plant

Water security is one of Peachland's highest priorities as the community continues to experience Stage 3 water restrictions. Peachland Lake has recovered significantly this spring, rising approximately 10 feet since April. However, the lake remains about eight feet below full pool, and with upland snowmelt now complete, the District expects water levels to gradually decline through the summer and into the fall.

While the District's water treatment and distribution systems continue to perform well, ensuring a reliable long-term water supply remains the challenge. Guided by the *2024 Water Demand and Supply Study* and ongoing updates to the *Water Master Plan*, the District is advancing long-term solutions, including expanding reservoir capacity, increasing water

Nations, and provincial agencies to strengthen water security across the Okanagan. Many of these solutions involve engineering studies, environmental reviews, regulatory approvals, and substantial investment before implementation.

Residents are thanked for their continued efforts to conserve water. Every litre saved helps protect our community's reservoirs during this extended drought. Unless significant rainfall occurs, Stage 3 water restrictions are expected to remain in place into the fall.

Do you have a water leak?

If there is text on your Utility Bill noting a continuous leak, this means your water meter is registering constant water usage. Since most homes are not using water continuously, this may indicate that you have a leak. The District cannot repair or assess leaks on private property, nor has information on where the leak is originating from. You are advised to call a plumber to investigate and repair the leak. All water usage, intentional or not, is the responsibility of the homeowner.

Childcare centre update

Project ahead of schedule & on budget



Construction on the Peachland BGCO Childcare Centre is ahead of schedule and is expected to be complete before the end of 2026. The project is also on budget and, barring any unforeseen circumstances in the next 5 months, expected to be slightly under budget when complete.

Interior finishes including painting, millwork, and lighting plumbing fixtures are underway. On the exterior, the landscaping includes natural grass and wood play areas, water play stations, play structures, rubberized surfacing and plantings.

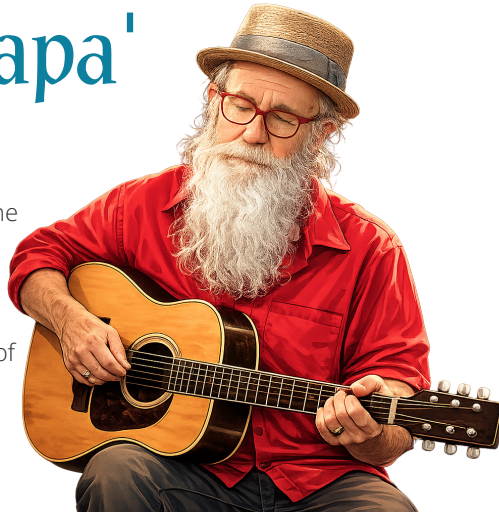

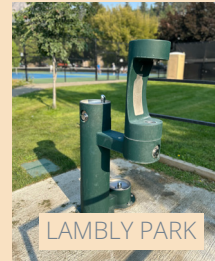
Stage named in honour of Keith 'Papa' Thom

Stay hydrated!

Boating & Water Safety

BE PREPARED

Know the safety rules for your craft; inform your guests, wear lifejackets, keep safety gear on board.

WATCH YOUR WAKE

Avoid creating obtrusive waves near other boats, swimmers or the shoreline. Keep the big wakes to the middle of the lake.

KEEP IT SLOW

Slow down when using the boat launch or approaching day mooring docks or public swimming areas.

STAY CLEAR

Boats and Sea-Doos must stay AT LEAST 30 metres from designated swimming areas. Boats are NEVER allowed in Swim Bay.

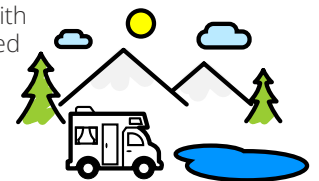

Recreational Vehicles: Best Suited for Campgrounds

Recreational vehicles are a great way to travel and enjoy the outdoors, but they are not intended to be used as permanent or temporary living accommodations. Occupying an RV or travel trailer on public or private property is only permitted where it complies with municipal bylaws. RVs must not be connected to municipal water, sewer, or electrical services unless specifically authorized. If you are considering listing an RV on a short-term rental platform, please note that RVs may not be used as short-term rental accommodations within the municipality. These requirements help protect neighbourhood character, support public safety, and ensure fair and consistent enforcement across the community. Residents with questions about permitted uses are encouraged to review District bylaws and/or contact Bylaw Services for more information.

Mayor's Message

Reflecting on this term and thanking those who made it possible

As we enjoy another beautiful Okanagan summer, I want to thank everyone who continues to make Peachland such a welcoming and resilient community.

July is a time to celebrate all that makes our town special, but it's also an opportunity to reflect on the work underway to ensure Peachland remains a great place to live for generations to come.

Two of Council's highest priorities continue to be water security and sewer servicing. Like communities across the Okanagan, Peachland is experiencing its fourth consecutive year of drought and remains under Stage 3 watering restrictions. I want to thank residents for doing their part to conserve water. The District continues to pursue both immediate and long-term solutions to strengthen our water system, including planning for additional water storage and exploring alternative water supply options. We also remain committed to advancing our sewer servicing strategy while advocating for provincial and federal funding to help reduce costs for homeowners.

This October marks the conclusion of the current Council's four-year term, and it's rewarding to look back at what we've accomplished together. Since 2022, Council has remained focused on responsible financial management, investing in infrastructure, improving public safety, supporting housing options, and strengthening our downtown while preserving the character that makes Peachland unique.

One achievement I'm especially proud of is our success in securing external funding. Over the past four years, we've brought more than \$33 million in grants to Peachland—one of the highest per-capita funding totals in British Columbia. Those dollars are helping improve roads, parks, trails, recreation facilities, childcare, seniors' housing, and critical infrastructure, while reducing the financial burden on local taxpayers.

Construction is underway on the highly anticipated 104-space Peachland BGCO Childcare Centre on Clements Avenue. Another exciting milestone is the upcoming construction of our new fire hall. This modern facility will significantly enhance emergency preparedness and provide our firefighters with the space and equipment they need to continue protecting our community for decades to come.

None of these accomplishments would have been possible without the dedication of District staff, volunteers, community organizations, our provincial and federal partners, and, most importantly, our residents. Your ideas, feedback, and willingness to work together continue to shape Peachland's future.

Thank you for making Peachland the remarkable community it is. I wish you and your family a safe, enjoyable, and memorable summer.

Council Highlights

June 9, 2026 - Regular Council Meeting

Community Wildfire Resiliency Plan

Council received a presentation by Forsite Consultants who were retained to complete a *Community Wildfire Resiliency Plan* (CWRP) for the District, funded through the Union of BC Municipalities' Community Resilience Investment program. Communities are required to have a CWRP to access FireSmart community funding and supports. The document serves as the primary wildfire risk reduction planning mechanism for BC communities. It identifies local wildfire hazard and risks to values and provides strategies to increase Peachland's understanding of wildfire risk, fosters great collaboration within and across administrative boundaries, increases Peachland's preparedness to respond to wildfire events and reduces the potential loss of homes, critical infrastructure and other important values. The plan does not involve analysis of wildfire risk on private property.

Minor OCP Review

Council gave first reading to the Official Community Plan (OCP) Bylaw and held a public hearing on the proposed bylaw on June 23. Peachland's OCP was adopted in 2018; it is typical to review OCPs every five to 10 years. The updated bylaw reflects the outcome of Peachland's Minor OCP Review which included public consultation. The review responds to both current provincial requirements and local planning priorities. It positions the District to meet legislative obligations and continue using the OCP as a clear and effective framework for future land use decision-making. As housing needs, provincial legislation, and local conditions continue to evolve, further amendments to the OCP will be required over time. Adoption of the proposed OCP bylaw will ensure Peachland has an updated and more user-friendly policy framework in place to guide growth, development, and community planning in the years ahead. In the future, the Province will require OCP updates every five years following the completion of regular housing need reports.

June 23, 2026 - Regular Council Meeting

Commercial Marine Launch Licensing Program

Council adopted bylaws to allow implementation of a Commercial Marine Launch Licensing program. The program is expected to preserve public access to boat launches at Swim Bay and Doggie Beach while enhancing oversight and accountability of commercial boat business operators. The amendments to the District's Business Licence, Bylaw Notice Enforcement, Development Application and Licence Fees and Park Regulation bylaws will align the District with regional neighbours who currently have similar programs to regulate commercial marine activities.
