

## Two More **Pickleball Courts Proposed** for Lambly Park

On January 28, Council directed staff to design and post a Request for Proposal for the construction for up to two pickleball courts at Lambly Park within the



currently allocated project budget of \$200,000, earmarked from Peachland's Growing Communities Fund grant received last year. Initially, the project was to include four courts with costs shared by the Peachland Pickleball Society. However, the Society didn't quite reach its fundraising goal but has indicated it will continue fundraising towards adding more courts in Lambly Park to keep up with the demand for the sport.

## Council Paving the Way for Child Care Centre on Wild Goose Street

On January 28, Council gave third readings to Official Community Plan and Zoning Amendment Bylaws for District-owned property at 5601 Wild Goose Street, a new road to be

created as part of the development of the Peachland Child Care Centre.

The new road is named after Wild Goose Bill, the first known settler on the land which later became Peachland. The road will lead to the centre adjacent to the Peachland Elementary School. The development application proposes an OCP amendment to Institutional and a Zoning amendment to P2 Public/ Institutional, which will allow the development of the Child Care Centre. A public hearing was held on the amendment bylaws on January 14, 2025. The application will now be scheduled for final adoption at an upcoming meeting once some conditions are satisfied.

## Thinking of a short-term rental?



Short-term rental (under 30 days) of a private room or a suite in a home is regulated under the Zoning Bylaw as Bed and Breakfasts.

There are two types of Bed and Breakfasts, a Traditional Bed and Breakfast with an individual room and a shared living facility, and a Suite Bed and Breakfast. Short-term rental of an entire dwelling, including a garden suite or recreational vehicle, is not allowed in Peachland.

The operator of the bed and breakfast must have a business license and the rental must be operated at the licensee's principal residence. It's important that the rental meets health and safety standards and does not adversely affect the community.

## PLEASE, Don't Flush This!

What we put down the drain can affect our drinking water. Help keep our water systems clean by being careful about what you put into the sewer system. This is referred to as "source control" which is a prevention technique that helps reduce contaminants. The same precautions should be taken whether on sewer or septic. Here's a list of items that should not be flushed or dumped down the drain.

#### **BATHROOM**

- Diapers, flushable wipes (they don't actually break down), rags, bandages
- Dental floss, cotton swabs, condoms, cosmetics Feminine hygiene products
- Pills and medicine (return to a pharmacist for disposal)

#### **KIITCHEN**

- Fats, grease, deep fryer oil, vegetable oil, cooking oil
- Lard, butter, salad dressing,

- marinade for meats
- Vegetables, meat, pasta, bread and other food waste items

#### **HOUSEHOLD ITEMS**

- Cigarette butts
- Paper towels, napkins
- Toys

#### **HAZARDOUS WASTE**

- Bleach and ammonia
- Cleaning solvents and spot removers
- Disinfectants
- Hot tub and swimming pool chemicals
- Oven cleaners
- Septic tank cleaners
- Latex, alkyd and/or oil-based
- Lacquers, stains and varnishes
- Paint thinners, strippers and
- Petroleum-based products such as motor oil and gasoline


# New Recreation Guide Available ONLINE ONLY

## Don't Forget to File New Speculation Tax Declaration

Peachland property owners must complete a *Speculation Tax Declaration* beginning this year. The Province announced the expansion of the tax to Peachland and other areas of BC in November 2023. Peachland property owners must complete the declaration they received from the Province by March 31. Most Peachland homeowners will be exempt from the tax because they live in their homes, but all homeowners still need to fill out the declaration every year. Taxes are applied if you do not live in the home you own in a speculation tax area, but there are exemptions. The tax is designed to discourage housing speculation or vacant homes. ## Mayor's Message

## Support for Sewer

As part of our commitment to improving local infrastructure, the Council is close to adopting the District's new Wastewater Master Plan and the long-awaited phasing plan to expand sewer servicing into all Peachland neighbourhoods.

While directly benefiting the over 1,600 properties on septic, this project will also ensure that the entire community of Peachland has better environmental protection, improved public health, and increased property values. Over \$35 million is needed for this undertaking. Some of the costs will fall on the property owner, Development Cost Charges will pay some, and a grant through the Okanagan Basin Water Board's Sewage Facilities Assistance Program will help offset a small portion of the overall costs. However, it is clear to the Council that it is essential that we receive funding support from our provincial and federal governments to complete the plan.

We are poised to do all we can to make this happen. Our provincial and federal representatives are very aware of our intentions for their support, and I have already begun the lobbying we need directly to provincial ministries and their federal counterparts. We are also researching the possibility of private sector involvement, liaising with other communities that have implemented this approach.

As we finalize the master plan, we will embark on a general survey this Spring. This survey is not just a formality, but a crucial step in our decision-making process. We are asking residents whose properties are still on septic systems about their interest in sewer servicing for their property and what they would be willing to pay for the construction, among other things. The results of this survey will help us determine phasing and approaches, and it is essential that we hear from as many impacted residents as possible. Your input is invaluable and will help us ensure residents are well-informed before the official Local Area Service (LAS) process.

If we successfully secure the funding, we will develop the LAS as required for sewer expansion in a neighbourhood. This process will be transparent, and properties that would benefit from the service will be polled, ensuring that all affected residents have a say in the project.

The new master plan considers historical promises in the proposed phasing and factors such as environmental impact and population density. We will also consider adjusting our bylaws (timeline) to allow residents' who recently updated septic systems time before being required to connect to the new system.

Since its first strategic planning meeting, sewer expansion has been a priority of this Council as it continues to be a top priority for almost half of our residents. We will soon have the plan, and The Council is laser-focused on getting the funding support Peachland needs to make this project happen.

## Council Highlights

## 4062 Beach Ave. Zoning Amendment

Jan. 28 - Council gave first three readings to a Zoning Amendment Bylaw to rezone 4062 Beach Avenue with some conditions. The proposed rezoning is from RM2 to CR3 to allow the construction of a six-unit multi-family residential development. The current zoning allows for four units. The applicant agreed to remove the requirement for commerical use at grade in the CR3 zone by restricting the principal uses to multi-unit residential and to limit heights.

### Road Closure Tailyour Lane

Feb. 11 - Council gave first three readings to a Road Closure and Removal of Highway Dedication Bylaw for Tailyour Lane in the Buchanan neighbourhood. The subject area is a 981 metre-squared portion of Tailyour Lane adjacent to Highway 97. It forms part



of the municipal road right of way but does not function as a transportation corridor. This closure stems from a discussion in 2023 on municipal revenue generation. If Council approves the road closure, the District can raise title for this area of land and add the newly-created parcel to the municipal land inventory as a potential development site. Community water and sewer service is readily available to the area which slopes gently down from Highway 97 towards the lake.

### Protective Services Building Borrowing Bylaw

**Feb. 11** - Council adopted a Protective Services Building Temporary Borrowing Bylaw to allow the deadline to borrow for the community's new fire hall to move past November 2027. Legislation requires borrowing to occur within five years of approval. In this case, approval was provided by Peachland voters in a 2022 referendum to borrow up to \$17.5 million for the new firehall. This temporary borrowing bylaw allows flexibility for the District to continue with the project without the immediate need to secure long-term debt, and would not require the withdrawal of funds until the project is ready for funding.
