- Proof of power source and sound impact (in decibels), if applicable
- Description of any anticipated or potential nuisances generated from the business (e.g. noise, dust, fumes, etc.)

ADDITIONAL REQUIREMENTS—FOOD VENDORS ONLY

- Proof of Municipal Fire Inspection (completed within 6 months of submission date)
- Copy of menu
